TERMS AND CONDITIONS FOR EXHIBITING

Article 1. DEFINITION OF TERMS

- "Exhibitor" shall mean a firm, a cooperative or an organization that has submitted the application form for participation in the exhibition.
- 2. "Exhibition" shall mean the "International Nuclear Energy Korea 2016".
- 3. "Organizer" shall mean BEXCO.

Article 2. APPLICATION AND PAYMENT PROCEDURES

The application form along with 50% of participation fee should be submitted to the Organizer located at 55 APEC- ro, Heaundae-gu, Busan (48060). The Organizer shall allocate spaces to Exhibitors whose applications were received before the application due date and in accordance with the space allocation standards. The remaining balance must be paid by the application due date, February 15, 2016.

Article 3. PARTICIPATION FEE

The participation fee is USD 2,000 per booth for space only and USD 2,500 per standards shell scheme booth.

Article 4. DESCRIPTION OF PARTICIPATION FEE

The participation fee shall include the space, 24-hour security for the exhibition hall, cleaning of the aisles, promotional activities and the provision of an exhibit directory.

Article 5. ALLOCATION OF EXHIBIT SPACES

- The organizer shall allocate exhibit spaces in consideration of the order in which the applications were received, the features of the items to be exhibited and other reasonable standards.
- If any special condition occurs, the space allocated to an Exhibitor may be changed at any time before the exhibitor move—in period. Such a change shall be made at the Organizer's own discretion and all claims for any such change are expressly waived by the Exhibitor.

Article 6. INSTALLATION AND REMOVAL

The installation and removal of the Exhibitors' facilities shall be completed within the stipulated period. Exhibitors shall pay the Organizer for any losses incurred due to a delay in installation or damage to the Exhibition Pavilion, due to removal, that is deemed the fault of the Exhibitors.

Article 7. COORDINATION OF EXHIBITS WITH ORGANIZER

Exhibitors shall provide descriptions of their exhibits before their construction and must ensure compliance with the regulations and restrictions on booth design and activities. Exhibitors shall also agree to provide the Organizer with the necessary information to facilitate the overall promotion of the International Nuclear Energy Korea 2016.

Article 8. INSURANCE, SECURITY AND SAFETY

Exhibitors are required to subscribe to all of the risk insurance policies related to all of the equipment and products to be used during the Exhibition as well as during set—up and take—down. Even through the Organizer shall devise appropriate security measures to protect the interests of the Exhibitors and visitors, the Exhibitors shall be held responsible for any loss, theft, or damage to any articles belonging to the Exhibitors. The materials used in the stands and displays must be properly fireproof in accordance with the local fire and safety regulations. The Organizer shall reserve the right to limit any construction or demonstrations that pose potential safety hazards.

Article 9. MANAGEMENT OF EXHIBITION BOOTHS

Exhibitors are bound to exhibit their announced products and to staff their stands with competent personnel during the opening hours of the Exhibition. The activities of the Exhibitor shall be confined to within the limits of the Exhibitor's booth. The exhibit will be consistent with the theme of the Exhibition, and the Organizer reserves the right to restrict exhibits that may detract from the general character of the Exhibition.

Article 10. SELLING OF ITEMS ON DISPLAY

It is agreed that the sole purpose for participation in the Exhibition is to display and/or demonstrate equipment, supplies and/or services. Cash sales within the confines of the allotted exhibit space are prohibited; however, selling within the special space allocated by the Organizer shall be excluded. All taxes and other affairs accompanying sales activities shall be the responsibility of the Exhibitor.

Article 11. LIABILITY

It is mutually agreed that the Organizer shall not be liable to the Exhibitors for any damage to and/or loss of the Exhibitor's property or for injuries to persons resulting from any cause. All claims for any such losses, damage, or injury are expressly waived by the Exhibitors

Article 12. CHANGE OR CANCELLATION OF EXHIBITION

The Organizer may cancel all or any part of Exhibition for any reason beyond its reasonable control, in which case the Organizer will refund to the Exhibitor a pro rata portion of any participation fees already paid to the Organizer. However, in case of compelling reason in particular force majeure, the Organizer is entitled to postpone, shorten, partially or completely close or to cancel the Exhibition, if and as far as the reasons are not in the Organizer's responsibility. In this case, the Exhibitor is not entitled to receive any reimbursement, and the Exhibitor shall not have any claim against the Organizer in respect of any loss or damage.

Article 13. CANCELLAION OF PARTICIPATION

- The exhibition participation contract may be terminated by the Organizer when the Exhibitor either wishes not to use the booth location which the Organizer allocated or violate the participation contract and the BEXCO EXHIBITIONHALL REGULATION including the payment schedule, then the Organizer reserves the right to cancel the contract.
- 2. In the event that the Exhibitor cancels all or part of the exhibit booth space contracted, the Exhibitor must submit a written notice of such cancellation and will be obliged for a cancellation fee as below:
 - Up to 30 days before the event : 50% of total participation fee
- Within 30 days before the event: 100% of total participation fee

Article 14. SUPPLEMENTARY REGULATIONS

The Organizer may establish supplementary/additional regulations in addition to these terms and conditions for exhibiting, and the Exhibitor shall observe them. The Exhibitor shall also observe the various regulations of BEXCO.

Article 15. SETTLEMENT OF DISPUTES

Any dispute that might occur between the Organizer and an Exhibitor concerning these 'Terms and Conditions for Exhibiting' or the mutual rights and obligations shall follow the ruling of the Korean Commerce Arbitration Board located in Busan, and its ruling is final and carries legal binding force to both parties.
